There were 18 approvals for non-recurrent expenditure, 11 approvals for recurrent expenditure, giving a total of 29 approvals for the year. Details of the approvals granted are given at Annex 1.

4. During 1994/95, 592 approvals of expenditure were granted by officers at, or above, the Assistant Director (D2) level, totalling \$1,072.60M with the highest amount approved being \$23.47M. Details of the approvals granted are given at the Annex 2.

8. The total domestic rent written off was \$0.59 million whereas the total non-domestic rent written off was \$0.23 million. The amount of domestic and non-domestic rent written-off is very small in relation to the total rents receivable. These write-offs were specifically approved under delegated authority by departmental officers under Financial Instruction No. 17 of 1993/94. The write-offs were necessary because the tenants had absconded or gone bankrupt or remained untraceable.
