AT1: Individual Term Paper (45%)

Each student is to write a term paper about the analysis of social indicator(s) in a unique area, following and probably going beyond steps suggested by the instructor. Accordingly, the term paper would apply a problem-solving approach to identify and tackle a social problem, review literature, present and analyze evidence, and assess the effectiveness of the solution helpful to discover useful insights.

AT2: Quiz (30%)

A quiz is to assess the student's grasp of essential concepts and other knowledge introduced in the course. It is necessary to ensure that the student has the foundation for performing other tasks.

AT3: Group Presentation (15%)

Students can form groups to report the general reflection on field visits. These presentations need to apply tone conducive to class discussions and new knowledge publicizing.

AT4: Class Discussion (10%)

Students are to contribute actively in the classes through insightful brainstorming and discussion.
