The aims of this course is

- a. to provide students with a structured opportunity to obtain practical experience from working in a law office or a legally related working environment, doing law related work relevant to their level of competence and experience and to enable potential employers to give structured feedback on the student's potential;
- b. to provide students with structured means to apply their knowledge into a new legal environment and discover solutions in practice;
- c. to prepare students to practice professionally in the legal field; and
- d. to develop the student's ability to apply academic knowledge in real life situations.

Grading of Student Achievement:

Students will be assessed on a pass/fail basis.

Percentage of coursework, examination, etc.: 100% coursework plus receipt of a satisfactory reference.

This course will be assessed by coursework. The student will complete a paper, with a maximum word limit of 2500 words, to be submitted to the General Office, SLW. The submission deadline will be notified by the Course Leader in due course. The subject of the paper must be agreed in advance with the student's academic supervisor and workplace supervisor and must relate to a substantive aspect of the legal work undertaken by the student during the placement. Before the coursework can be assessed the Course Leader must receive a satisfactory reference from the student's workplace supervisor. Therefore, in order to pass this course the student must achieve a satisfactory reference from the workplace supervisor and must gain a minimum of 40% for the coursework.

4	Application procedure
5	a. SLW allocated placement: The SLW will invite applications for the Legal Placement for the Summer Term and the application will be arranged in March/April every year or other times as necessary or appropriate. SLW allocated placements may be available (subject to availability) during Semester A and/or Semester B. Application times will be announced by email.
6	b. Join-in: The student should submit the application two weeks (or in special cases and subject to approval, as soon as possible, but must be) before the start of the "join-in" internship. No application of "join-in" will be considered for past experiences or placement that had already begun. The student must include the following in the application (which could be a letter and/or email from the placement organisation that clearly states):
7	i. The name of the organisation;
8	ii. The length of the agreed work time;
9	iii. A written confirmation from the organisation stating the name and Hong Kong ID card number of the student, and the agreed work time;
10	iv. A written confirmation from the organisation stating that they will participate in the assessment of the student;
11	v. A written consent from the organisation allowing the student to be enrolled in a credit-bearing Legal Placement programme during the time at which the student is working with them; and
12	vi. A separate declaration letter from the student that they will comply with the requirements (e.g. assignments cost, etc.) of the Legal Placement course and the syllabus thereof.
