Remark:

Participating students shall pay tuition fees and any other study related costs (if any) to CityU. They shall also be responsible for their own financial support including transportation, accommodation, living expenses, insurance, visa (if necessary) and medical expenses for their participation in the outgoing exchange activity.

The outbound exchange students are required to pay a Caution Money of HK\$1,000 when they accept the exchange offer from the University. Students will receive a reimbursement of the Caution Money if and when they have completed the exchange programme with satisfaction, and submitted all the required documents to the University upon completion of the exchange programme. Should student fail to meet any of the above stated requirements or decide to withdraw from the programme after accepting the offer, even before or after departure, the Caution Money will be forfeited.
