### Highlights of Events (Jul – Dec 2023)

Guangdong-Hong Kong-Macao Greater Bay Area Legal Forum 2023: Building a Rule of Law-based Bay Area and Creating New Prospects for Development 28 July 2023

This prestigious forum, held on July 28, 2023, commemorated the ongoing development of the Guangdong-Hong Kong-Macao Greater Bay Area. Themed "Building a Rule of Law-based Bay Area and Creating New Prospects for Development," it aimed at bolstering the rule of law to promote regional growth and future prospects. Professor Lee Chun Sing, Provost and Deputy President of City University of Hong Kong, and **Professor Lin Feng**, Dean of the School of Law participating online, inaugurated the forum.



The Decision-Makers Forum commenced post-opening, spearheaded by **Professor Zhu Guobin**. Keynote speeches were delivered by prominent figures such as **Mr. Horace Cheung Kwok-kwan**, **Ms. Leung Wing Yin**, **Ms. Eunice Yung Hoi-yan**, **Mr. Victor Dawes SC**, **Mr. Chan Chak Ming**, **Professor Mo Jihong**, and **Dr. Bian Fei**, focusing on the rule of law and cooperative development in the Greater Bay Area.

Subsequent sessions delved into diverse legal aspects. The first session, led by **Professor Mo Jihong**, explored legal cooperation theories and practices. The second session, moderated by **Professor Du Chengming**, focused on rule convergence, followed by the third session on Judicial Cooperation, overseen by **Professor Zou Pingxue**. The fourth session, led by **Professor Guo Tianwu**, discussed legal service industry cooperation. The final session, chaired by **Professor Yang Xiaonan**, concentrated on comprehensive construction in the Greater Bay Area.

The forum concluded with closing remarks by **Professor Guo Tianwu** and **Professor Zhu Guobin**, celebrating the forum's success and the collaborative spirit towards the Greater Bay Area's development. The event was a melting pot of ideas, fostering deeper understanding and consensus on the rule of law's role in the region's advancement.

# CPLR Co-organizes Landmark Conference on the Influence of Soviet Law Model on Modern Legal Systems

3 October 2023

In a significant academic event co-organized by the City University of Hong Kong's Public Law and Human Rights Forum (CPLR) and VNU University of Law, Hanoi, **Professor Zhu Guobin** presented a notable keynote address. The conference, held at VNU University of Law in Hanoi and accessible online, focused on the influence of Soviet law on modern legal systems. Professor Zhu's speech, titled "*The Soviet DNA in Contemporary Chinese Constitution through the Lens of Two Concepts and One Institution*," delved into the impact of Soviet constitutional principles on China's legal framework. His insights highlighted how Soviet legal concepts have been integral to shaping China's socialist constitution. This event, a collaborative effort between CPLR and VNU University of Law, provided a platform for exploring the historical and ongoing influences between Soviet and Chinese legal systems. Professor Zhu's contribution significantly enriched the discussions, underlining the complex interplay of legal doctrines across different jurisdictions.

# Public Law and Human Rights Book Review Seminar Series (5) – Crime and Control in China: The Myth of Harmony (Polity 2022) by Børge Bakken

The fifth seminar in the "Public Law and Human Rights Book Review Series," co-organized by the CPLR and the APLR, focused on the book "Crime and Control in China: The Myth of Harmony" by **Børge Bakken**. This event, aiming to promote scholarly exchange and publicize notable works in Public Law and Human Rights,

attracted a diverse audience of academics and students. The seminar was held online via Zoom on October 19, 2023, from 5:00 pm to 6:00 pm (HKT).

Author Børge Bakken presented a critical analysis of the discrepancy between the reported low crime rates in China and the country's reality of high inequality and potential instability. He questioned the narrative of a harmonious society by exposing how crime statistics are manipulated and controlled by the authorities. Reviewer Enshen Li, alongside Bakken, engaged in an in-depth discussion about the complexities of crime and control in China, challenging the conventional understanding of these issues.

The seminar offered valuable insights into the often-misunderstood aspects of Chinese society and law enforcement, making it a significant contribution to the ongoing dialogue in the fields of law and criminology. Participants were encouraged to join via a provided Zoom link and engage in this enlightening discussion.

On October 26, 2023, the City University of Hong Kong's School of Law hosted an illuminating seminar entitled "The Relationship between the Chinese Constitution and the Hong Kong Basic Law: A Theoretical Review over Forty Years." The event took place in the LI-6301 Seminar Room and was moderated by **Prof. Huang Tao.** 

**Prof. Huang Mingtao**, a renowned expert from Wuhan University, was the keynote speaker. He provided a comprehensive analysis of the evolution and interconnections between the Chinese Constitution and the Hong Kong Basic Law, covering their developments over the past forty years. His presentation offered a deep

dive into the constitutional dynamics and their application within the Hong Kong Special Administrative Region.

Joining the discussion were **Prof. Zhu Guobin** from CityU's School of Law and **Prof. Zhu Han** from the University of Hong Kong. Their contributions added depth to the seminar, presenting varied perspectives on the constitutional framework and its implications for Hong Kong.

This seminar, part of the Public Law and Human Rights Forum's mission, fostered a multidisciplinary dialogue among legal scholars and students. It underscored the forum's commitment to being a leading institution in Asia for public law and human rights research, emphasizing global collaboration and knowledge exchange. The seminar's success was evident in the rich discussions and engagement from over twenty CityU students and faculty members.

## Symposium on the Leading Edge of Research and Publishing in 'One Country, Two Systems' and the Rule of Law in Hong Kong

On December 9, 2023, the School of Law, City University of Hong Kong, in collaboration with Joint Publishing (Hong Kong) Limited, successfully hosted a symposium titled "Adherence to Principles and Innovation." The event, organized by the Public Law and Human Rights Forum, delved into the 'One Country, Two Systems' policy and the rule of law in Hong Kong.

On December 9, 2023, the School of Law, City University of Hong Kong, in collaboration with Joint Publishing (Hong Kong) Limited,

successfully hosted a symposium titled "Adherence to Principles and Innovation." The event, organized by the Public Law and Human Rights Forum, delved into the 'One Country, Two Systems' policy and the rule of law in Hong Kong.

Opening remarks were made by Ms. Janice Yip Pui-chu and Professor Zhu Guobin, setting the stage for a series of in-depth discussions. Key themes included the Chinese Constitution and the Basic Law of Hong Kong, with notable contributions from Professor Priscilla Leung Mei-fun and Professor Rao Geping. They emphasized understanding the 1982 Constitution and its application within the context of Hong Kong's unique legal environment.

The symposium also explored the Hong Kong legal system under 'One Country, Two Systems,' highlighted by insights from **The Hon Ronny Tong Ka-wah** and **Professor Albert Chen Hung-yee**. They addressed the harmonization of Hong Kong's common law system with mainland China's legal framework and the implications of the National Security Law.

A session on the Hong Kong National Security Law and Rights Protection featured **Professor Zhu Guobin** advocating for a comprehensive legal framework respecting common law values. The symposium concluded

with perspectives on Hong Kong's and Taiwan's roles in the international arena, stressing the importance of continuous research and writing in these areas.

This pivotal event highlighted the ongoing development and challenges within Hong Kong's legal landscape, fostering a deeper understanding and dialogue among scholars and legal experts.
