Part II Course Details

Abstract

This course explores major Chinese classic works, as well as their historical context, genre and major characteristics. Studying the classics is the best and effective way to understand the core values of Chinese traditional culture which form the basis of the minds and behaviours of the Chinese people at large, both past and present. In addition, all selected works are written in traditional Chinese. It aims to enhance students' Chinese ability in order to provide a good foundation for their learning in the forthcoming four years.

2	Tutorials	<p>All tutorials are topic-oriented. Students are expected to study the assigned readings in advance, and all of them will take turns to be the presenter and lead the discussion throughout the course. Teachers will assess students' analytical skills and their understandings of assigned readings. Tutorials ensure that there is sufficient teacher-learner interaction and peer discussion. Group presentations and discussions will be conducted during tutorials. Both the oral and written presentations will be assessed. This assessment will grade on content and fluency of presentation as well as the well organised and coherent of the assignment. The group delivering presentation must have thoroughly studied and researched their topic and worked as a team on the collection, reading, selection, integration, analysis of the resources. They require showing their abilities to lead the classmates into participating in the discussion, to explain with Rich content, excellent grasp of the materials with in-depth or extensive knowledge of the subject matter; rigorous organization, coherent structure, balanced composition and to criticize and analysis with convincing statement and creative comment.
